4. OBJECTIVES OF THE TRUST:


In order to fulfill our broad objective, the trust will undertake following activities and functions: -

10. FINANCE & ACCOUNTS:-

- (d) The TRUSTEES shall cause true and accurate accounts to be kept of all moneys, received and spent and or all matters in respect thereof in the course of the management of the Trust property or in the Trust as well as of all assets, credits and effects of the Trust property.
- (e) The according year of the Trust shall be financial year that is year ending 31st March every year.
- (f) A firm of Chartered Accountants, appointed by the TRUSTEES shall audit the accounts of the Trust every year.

11. APPLICATION OF TRUST PROPERTY / INCOME: -

It is expressly declared that no part of the Trust property or income of the Trust shall be applied for any purpose outside India or for any purpose which is not a public charitable purpose in law and all provisions hereof shall be construed accordingly.
